Headedness and/or grammatical anarchy? Ulrike Freywald 2022-10-20 In most grammatical models, hierarchical structuring and dependencies are considered as central features of grammatical structures, an idea which is usually captured by the notion of “head” or “headedness”. While in most models, this notion is more or less taken for granted, there is still much disagreement as to the precise properties of grammatical heads and the theoretical implications that arise of these properties. Moreover, there are quite a few linguistic structures that pose considerable challenges to the notion of “headedness”. Linking to the seminal discussions led in Zwicky (1985) and Corbett, Fraser, & McGlashan (1993), this volume intends to look more closely upon phenomena that are considered problematic for an analysis in terms of grammatical heads. The aim of this book is to approach the concept of “headedness” from its margins. Thus, central questions of the volume relate to the nature of heads and the distinction between headed and non-headed structures, to the process of gaining and losing head status, and to the thought-provoking question as to whether grammar theory could do without heads at all. The contributions in this volume provide new empirical findings bearing on phenomena that challenge the conception of grammatical heads and/or discuss the notion of head/headedness and its consequences for grammatical theory in a more abstract way. The collected papers view the topic from diverse theoretical perspectives (among others HPSG, Generative Syntax, Optimality Theory) and different empirical angles, covering typological and corpus-linguistic accounts, with a focus on data from German.

Morphosyntactic Change Bettelou Los 2012-05-03 Particle verbs (combinations of two words but lexical units) are a notorious problem in linguistics. Is a particle verb like look up one word or two? It has its own entry in dictionaries, as if it is one word, but look and up can be split up in a sentence: we can say He looked the information up and He looked up the information. But why can't we say He looked up it? In English look and up can only be separated by a direct object, but in Dutch the two parts can be separated over a much longer distance. How did such hybrid verbs arise and how do they function? How can we make sense of them in modern theories of language structure? This book sets out to answer these and other questions, explaining how these verbs fit into the grammatical systems of English and Dutch.

Interfaces in Functional Discourse Grammar Lucia Contreras-García 2021-08-23 In grammar design, a basic distinction is made between derivational and modular architectures. This raises the question of

which organization of grammar can deal with linguistic phenomena more appropriately. The studies contained in the present volume explore the interface relations between different levels of linguistic representation in Functional Discourse Grammar as presented in Hengeveld and Mackenzie (2008) and Keizer (2015). This theory analyses linguistic expressions at four linguistic levels: interpersonal, representational, morphosyntactic and phonological. The articles address issues such as the possible correspondences and mismatches between those levels as well as the conditions which constrain the combinations of levels in well-formed expressions. Additionally, the theory is tested by examining various grammatical phenomena with a focus both on the English language and on typological adequacy: anaphora, raising, phonological reduction, noun incorporation, reflexives and reciprocals, serial verbs, the passive voice, time measurement constructions, coordination, nominal modification, and connectives. Overall, the volume provides both theoretical and descriptive insights which are of relevance to linguistics in general.

Phi-features and the Modular Architecture of Language Milan Rezac 2010-11-12 This monograph investigates the modular architecture of language through the nature of "uninterpretable" phi-features: person, number, gender, and Case. It provides new tools and evidence for the modular architecture of the human language faculty, a foundational topic of linguistic research. The book is organized thematically with two chapters on each topic: The grammar of the Scandinavian languages (Tor A. Åfarli and Christer Platzack); language policies and sociolinguistics (Unn Røyneland and Peter Trudgill); French (Hans Petter Helland and Christine Meklenborg Salvesen); language change (Werner Abraham and Elly van Gelderen); lesser-studied languages (Alice Harris and Jerry Sadock); language acquisition (David Lightfoot and Marit Westergaard); and language evolution (Erika Hagelberg and Salikoko Mufwene). This book will be of interest to a wide range of readers, from students to scholars working on any of the areas covered.
